**Subject: Request for Quotes #2356-A: Grass Cutting - East Fayette
Addendum #2**

Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced RFQ. You will need to consider this information when preparing your quote.

1. **Is spraying required?**
Yes. Vendor is required to spray the cracks in the concrete, and any other areas specified in the scope of work.
2. **Is it a one-year contract?**
This is a 16 month contract, (#18 term of contract, the terms and conditions will be updated in the final contract.)
3. **Maintenance will the clean up of hedges be part of the scope?**
No.
4. **What about leaf cleanup?**
Leaf cleanup is only required during the contracted mowing months.
5. **The RFQ dates change what is changed?**
Only the dates changed due to the inclement weather.
6. **Will the tree next to the property line be removed?**
Yes.
7. **How far into the trees do we maintain?**
To the edge of the mature tree line.
8. **The wet areas, do we address them when they are dry? Or what do we do if it's out each week?**
These areas are to be maintained per specifications just like the rest of the areas.
9. **Can we cut on the weekends?**
Mowing shall be completed on the same day of the week every week. This day can be negotiated once the contract is awarded.
10. **If we miss a cut completely, do we lose that cut or does it go to the end of the contract?**
The contractor will lose that cut.

11. **Is initial cleanup required?**

No.

12. **What about the high brush areas?**

The county will cut down and maintain this area before the contract starts.

13. **Do we only cut the open fields?**

No, you cut the entire property that we walked.

14. **Is workers comp required with bid submitted?**

No. Insurance certificates are not submitted with the quote. They are required later on in the process by the winning bidder.

15. **Will rear fenced in area be accessible at 7am?**

Yes.

16. **Are you going to have a separate company to quote a chemical turf program?**

No. The contractor will maintain the only field at this location.

17. **Are the parking areas expected to be sprayed?**

Yes, per the scope.

18. **Are you planning to repave the rear of the Health Center?**

This is unknown at this time, and is not included with this scope of work.

19. **Do insurance certificates need to be submitted with the quote?**

Please see question #14.


