Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced ITB. You will need to consider this information when preparing your bid.

#### **Questions Before the Pre-Bid Conference:**

1. Are these new courts? Yes

#### 2. Time Frame?

**Schedule** – The project shall commence within thirty (30) calendar days of the Contractor receiving the Notice to Proceed (NTP) and shall reach final completion within **One Hundred Seventy-Five (175) Calendar Days** of the Contractor receiving the NTP from Fayette County. Contract time is measured on a Calendar Day basis and includes County Holidays and weekends.

#### 3. How many other contractors are bidding on the project?

The county advertises on its website and the Georgia Procurement Registry and other outlets so it is difficult to tell how many bids we will receive. The county will post the attendees sheet for the pre-bid conference once the meeting is completed.

## 4. Is this all-in grade, or will this be core-drilled?

Compaction of sub grade will be the responsibility of the contractor and shall be compacted to 100% modified proctor. Once compaction testing has been completed by the contractor and the results verified by the owner, the courts base material may be applied. The base material shall be compacted to 98% modified proctor, or better. Compaction and materials testing may be paid for out of allowance pay item 31.

#### 5. FYI, on the Bid Sheet, #24 (3' tall Chain Link) is 180lf, not 80lf.

The Bid Sheet has been revised to reflect 180-If of 3-ft chain link fence, and is attached (Attachment 1) Use the revised Bid Sheet to submit your bid.

#### **Questions Received at the Pre-Bid Conference:**

#### 6. Is this the parking that is shown on the drawings?

As stated in the ITB, Fayette County Road Department has constructed the parking lot by grading, installing C&G, and placing asphalt, striping, and wheel stops. Yes, the new asphalt parking and curb & gutter (C&G) completed at the site is the parking and C&G shown on the plans.

## 7. Is Fayette County doing anything with the hill?

No. The County will not do any additional grading or work with the existing hill.

#### 8. Is there ADA access for the sidewalk?

The concrete sidewalk and wheelchair ramp will be the responsibility of the contractor. Refer to the plan sheets and Pay Items 14 and 15. As stated in the ITB, the contractor shall verify all grades to exacting tolerances as specified for the Americans with Disabilities Act.

## 9. Will there be any more curb and gutter?

No. Refer to Question 6.

## 10. Is the well demo completed?

As stated in the ITB, Fayette County Road Department has completed demolition and removal of the well and pump house. Yes, demolition of the pump house and well is complete. Fayette County Water System will remove the abandoned watermain prior to construction.

## 11. Is there a dateline that you want it turned over to the County?

## 12. Are you bidding the Playground as well?
