Contract 2367-A: Crosstown WTP Second Floor Flooring

The Purchasing Department issued Request for Quotes 2367-A to secure a contractor to install new flooring in the main hall and laboratory at Crosstown Water Treatment Plant. Notice of the Opportunity was emailed to 46 companies. Another 443 were contacted through the web-based Georgia Procurement Registry, who had registered under commodity code 36025 (Linoleum) and 36085 (Floor Covering, Floor Covering Installation). The offer was also advertised through Georgia Local Government Access Marketplace and the County website.

Five companies submitted quotes (Attachment 1) to install new LVT and CVT. Special flooring is required in the laboratory due to the chemicals. To increase the longevity of the flooring, Water System is requesting to award the alternate to removing the existing flooring before installing the new flooring rather than floating the new flooring product over the old flooring.

The Water System recommends awarding to the lowest responder, Select Floors, Inc. A Contractor Performance Evaluation is not available since this is the first time contracting with Select Floors. The Purchasing Department checked their references, and the results were favorable.
