**Subject: Contract 2412-A: S. Fayette Vegetation Clearing**

The Purchasing Department issued Request for Quotes 2412-A to secure a contractor to remove vegetation along a portion of the fence at S. Fayette Water Treatment Plant. Notice of the Opportunity was emailed to 30 companies. Another 1,112 were contacted through the web-based Georgia Procurement Registry, who had registered under commodity code 98888 (Tree Trimming and Pruning Services). The offer was also advertised through Georgia Local Government Access Marketplace and the County website.

Eleven companies submitted quotes (Attachment 1). The Water System recommends awarding to the lowest responder, Quality Diversified Services. A Contractor Performance Evaluation is not available since this is the first time contracting with Quality Diversified Services. The Purchasing Department checked their references, and the results were favorable.
