Subject: ITB #2424-B: HIP and Microsurfacing 2024 Addendum #1

Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced ITB. You will need to consider this information when preparing your bid.

- 1. Can we substitute the GA DOT specification with the NYS DOT specification NY Item 417.01 (Heater Scarification) and 417.0101 (Recycling Agent). We can't bid the job with the GA DOT specification. GA DOT standards are required in this contract. However, we are open to suggestions to amend the current GDOT HIP specifications to meet the specific requirements of your companies HIP process. Please use the provided exceptions page.
- 2. If you receive no bids and re-let the project, can you separate the HIPR from the overlay and let them as 2 separate contracts. We don't bid as a GC. In future bids we may consider this request.
- 3. Will you take cores that the winning bidder can use for mix design testing? Or will the winning bidder be required to take the cores. Yes, we will provide 2-4" cores.
- 4. Can the requirement to begin work within 30 days of receiving the notice to proceed be waived should the winning bidder want to do the work in early spring and still meet the June 20th, 2025, completion date? The requirement to begin work within 30 days is hereby rescinded.
- 5. What is the total pavement thickness? We need a minimum of 3" to HIPR at 1-1/2". The existing thickness is between 5" to 7".
- 6. Is the HIPR depth 1-1/2". Yes
- 7. What is the pavement width? Majority of the road is 24', one section next to SR85 is 36'.
- **8. Are there any epoxy or Urethane pavement markings requiring removal.** There are existing thermoplastic pavement markings.
