Subject: RFQ #2462-A: Asphalt Milling Addendum #1

Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced RFQ. You will need to consider this information when preparing your quote.

- 1. The current bid schedule request an hourly milling price- with the document describing milling up to 3.5" but then it ask for a SY price for the additional depth over 3.5" by the SY. Hourly milling cover the machine being there for the time that it is working- the deeper the milling, the longer it takes for the machine to complete the task- because the county is providing the trucking- the depth does not make a time difference to the contractor because the less than 10,000 is being paid for by the hour. In the past this bid has had that item as a SY item- is the county wanting the 10,000 SY or less milling priced by the hour- if so- the item for additional depth is mute. Or does the county want that item by the SY as it has been done in the past. The Price Sheet milling additional line has been removed, See Attachment.
- 2. The county has elected to be responsible for most of the SOW. Does that include traffic control; flagmen, signs, etc? Fayette County will handle all traffic control including signs and flagmen under primary intent of this bid package. The County is requesting a cost estimate from the contractor for providing these services in case the County is unable to complete them as outlined in the primary bid package.
- 3. Is the contractor to provide only the milling machine with operator? Does the county supply and deliver the needed water for milling machine? If contractor is to provide water truck, that should be included in price. (It would be much simpler if county provided the hydrant meter for contractor use while on the job.) We are expecting the contractor to supply the required staff necessary to perform the required milling work. The contractor shall include the cost of supplying water to operate the milling machine within the quoted unit prices. Fayette County does not have water hydrants on every road in the County.
- 4. Is a bid bond required for this project? No, a bid bond is not required for this project.

5. Fayette County requests that the milling machine specified in this bid package be at least 7 feet wide to accommodate all milling operations, including edge milling and patching.
