Gentlemen/Ladies:

Below, please find responses to questions, clarification, or additional information for the above referenced Request for Quotes. You will need to consider this information when preparing your quote.

- 1. For the total project amount: should we exclude the alternate from the total sum. (Alternate: painted terminal posts). See Attachment 1
- 2. Does the fencing at the stairs have to step down or can it be continuous? It can be continuous.
- **3.** Clarify painting on Terminal Posts. Paint terminal posts from dugout to dugout. This will be part of your alternate bid.
- **4. Will wooden beams/posts be replaced?** Wooden posts should be removed and replaced with metal posts.
- 5. Extensions for Field 1. Fencing on Field 1 will be extended 30ft past the current 10ft fence on each side. Fencing on Field 3 will be extended past the current 10ft fence on each side where the dirt infield and grass outfield meet.
