2. Bid item #700-9300 what type of sod?

Bermuda Sod.

3. At the casing numbers requested for open cut?

Yes, the casing line item is intended for open cut circumstances.

4. What was the actual annual contract pay out totals for the past three years?

Water Annual Contract Award FY 2022 \$1,367,205.00 Water Annual Contract Award FY 2023 \$1,870,800.00 Water Annual Contract Award FY 2024 \$2,057,880.00

5. When does the new annual contract take effect? July 1, 2025.

6. Is a soil sample required before adding fertilizer?

No, a soil sample is not required before applying fertilizer.

7. Is there a detail for the water boost pump station?

This item is omitted from the updated bid schedule.

8. What material is needed when we abandon a manhole? Dirt; 57 stone;

When approved for abandonment and prior to backfilling, the bottom of the structure shall be broken up in such a manner that water will readily pass through and all pipes entering the manhole shall be plugged or grout filled. The top portion of the manhole structure shall be removed in order to establish a minimum of 3 feet cover from subgrade or finish grade when not under the pavement; and filled with granular embankment (sand) or suitable backfill material that can readily meet the requirements of GDOT Section 208.

9. Is there an Excel version of the Bid Schedule for the subject ITB available?

Yes. An Excel version of the updated Bid Schedule is provided. (Attachment 1)

10. Can you please explain what is the TA-1 through TA-18 stand for on the Traffic Control Items?

The "TA"-numbers correlate to MUTCD typical applications of Temporary Traffic Control activities. These typical applications illustrate a variety of situations commonly encountered. The information illustrated can generally be adapted to a broad range of conditions. In general, the procedures illustrated represent minimum solutions for the situations depicted.

11. What does ED stand for in the unit of measurement for the Traffic Control items?

"ED" stands for Each Day.
