Subject: 984-R1 First Renewal: Contract for Fire / EMS Uniforms

On May 15, 2014 the county entered into a contract with T&T Uniforms South for new uniforms for Fire and EMS employees. The Purchasing Department had solicited price quotes from eleven companies, but only T&T responded.

The contract expires on June 30, 2015. Fire / EMS Services wishes to renew the contract, and T&T has stated they are willing to renew at the existing prices.

The not-to-exceed amount in the first year of the contract was \$40,305. While unit prices will remain the same, Fire / EMS Services calculated that they need to set the not-to-exceed amount for the upcoming year at \$55,600. Funds are available in the recommended Fiscal Year 2016 budget.

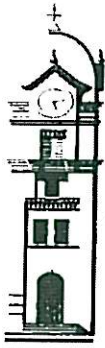




1. This contract was made effective the day of May 15, 2014.
