Subject: RFP #1112-P, Target System for Outdoor Shooting Range – Addendum #1

Dear Gentlemen/Ladies:

Included herein is additional information and clarification for the above referenced request for proposal. Please consider all of this information when preparing your proposal.

- 1. What is the line spacing for the target system, meaning what is the planned distance from the center of one target to the next and the space on each end?**
4 feet from center to center of targets and 6 feet from center of target to next shooting lane target center.
- 2. Multiple target systems are used by law enforcement nation-wide, some are 90 degree turning and some 180 degree, which will be the ideal system for Fayette County? (180 degree allows you to have a civilian on one side and a "bad guy" on the other to help with decision making under pressure.)**

Please propose the system that you believe best meets the needs of Fayette County, as indicated by the information contained in the Request for Proposals. As stated in Section E, Proposal Response Requirements, Item 3 says, to describe the system you propose, and how it will meet the county's needs. It says, "Include any items or work not specifically mentioned in this Request for Proposals, but which you decide should be included, or would present the best solution." Please describe the target system you do propose, and its advantages.

The county is looking for a quality target system for training Sheriff's Office personnel, but one that recognizes there are financial boundaries. As stated in Section F, Evaluation Criteria, 70% of evaluation scores will be based on technical merit, which underscores the value of an appropriate solution to our need. The 30% of scores based on price indicates that, like other jurisdictions, we must be mindful of the cost of the system.

- 3. If the 180 degree has not been discussed or considered, is there an opportunity to submit 2 separate bids on each system?**

Please submit only one proposal. This should be the target system which you provide, which you believe best meets the needs stated in the Request for Proposals, considering both technical merit and price.


