Gentlemen/Ladies:

Included herein is additional information and clarification for the above referenced request for proposals. Please consider all of this information when preparing your proposal.

**1. Fayette County is soliciting proposals from GDOT pre-qualified consultants; are there particular area-classes that you are interested in?**

The Consultant (either the prime or one or more of the sub-consultants on the project team) shall be prequalified in the following GDOT area classes:

- 1.02 Urban Area and Regional Transportation Planning
- 1.06(a) NEPA
- 1.07 Attitude, Opinion, and Community Value Studies (Public Involvement)
- 1.10 Traffic Analysis
- 1.13 Non-Motorized Transportation Planning
- 3.01 Two-Lane or Multi-lane Rural Roadway Design
- 3.02 Two-Lane or Multi-lane Urban Roadway Design
- 3.06 Traffic Operation Studies
- 3.13 Facilities for Bicycles and Pedestrians

**2. Is there a page limit for the proposal?** There is no page limit.

**3. Under Terms and Conditions, #9 it states that we shall submit a list of three (3) jobs that are of the same or similar nature. Are these one in the same as the References Form?**

Yes, the Reference Form is the template for documenting the Reference requirement of item 9. They are one and the same.

**4. Under Proposal Requirements, 3. Experience we are to summarize the team's relevant experience. Can the relevant experience be in addition to the projects used on the Reference Form?**

Yes; Proposal Requirement No. 3 – Experience: is the opportunity for the Consultant Team to document any or all experience they have that may be

relevant to this project. There is no set format for this section. Consultants can provide as much or as little as they think appropriate for the proposal. The same projects identified on the Reference Form may be described here with explanation, pictures, etc.

5. **Can you please clarify if we are to submit ONLY 3 or AT LEAST 3 projects for Experience?** There is no minimum or maximum number required for the Proposal Requirement No. 3 – Experience section, although a proposal with zero projects will probably not score very well.

For clarification, the information provided in response to **Proposal Requirement No. 3 – Experience** is used by Fayette County to score and rank the proposals. The references provided in response to **Terms and Conditions No. 9** is used by Fayette County to verify the information provided in the top-ranked proposals. The reference check is not scored but rather a pass/fail test prior to recommending Contract award.


