1. Call to Order by Chair Randy Ognio

Chairman Ognio called the July 14th, 2020 Transportation Committee Meeting to order at 2:01 pm.

2. Ascertainment of Quorum

Chairman Ognio acknowledged that a Quorum of the Transportation Committee was present.

3. Acceptance of Meeting Agenda

Mr. Mallon made a motion to move item number 8, GDOT Project Status Updates, to after item 4, the review and approval of the July 14th Transportation Committee meeting minutes. Ms. Robinson seconded the motion. The motioned passed unanimously.

4. Review and Approval of the March Transportation Committee Meeting Minutes

Mrs. Robinson moved to accept the July meeting minutes. Mr. Sas seconded the motion. The motioned passed with Ms. Tapp, Mr. Hindman, and Mayor Laggis abstaining.

5. Report of Committee Members / SPLOST updates

a. Brooks

The remaining SPLOST projects include paving the gravel section of Friendship Church Road and a realignment of the Highway 85 Connector and Brooks Road intersection. Mr. Ungaro stated the SPLOST projects are on hold until funds can be collected.

b. County

- Ebenezer Church Road Bridge ROW work is underway; County is waiting on GDOT approval of the detailed cost estimate.
- East Fayetteville Bypass An internal GDOT meeting was held on July 28th. We are waiting on letter from GDOT for details of action needed to move forward.
- Hampton Road and SR 92 The concept was approved by the Board of Commissioners on July 23rd and is in the design phase.
- Redwine Tunnel County has reviewed the concept and is evaluating use of alternate materials.
- Resurfacing 2019 The contract has been awarded but County is waiting on the Notice to Proceed from GDOT.
- Resurfacing 2020 Bid due date has been extended to August 12, 2020.

c. Fayetteville

Mr. Hindman stated the city is completing eight miles of resurfacing, the Wastewater Plant upgraded is 64% complete, and the city hall construction is still on schedule for an April 2021 completion.

d. Peachtree City

Ms. Robinson the gateway bridge is coming along. Peachtree City would also like to keep the SR 74 at Aberdeen Parkway (FTP-300) as a project on the 5 Year Plan and would like to revisit the verbiage for the Peachtree Parkway roundabout (FTP-367). The city would like to change this from roundabout to intersection improvement.

During group discussion, Mr. Smith noted the following additional items:

- 1. The two roundabouts on SR 92 are scheduled for completion in June 2021.
- 2. The culvert work on SR 54 near Flat Creek Trail is nearly complete.
- 3. The dip on SR 85 southbound (near Seay Road) is scheduled to be paved in September.
- 4. The Department's maintenance budget was not reduced as much as first thought. There are no anticipated impacts to GDOT ROW maintenance, including grass cutting and trash pick-up.
